Directions:

1. Always pre-test all cleaning solutions in an inconspicuous area for colorfastness prior to application.
2. Select and apply the appropriate HydraMaster preconditioning pre-spray solution first.
3. For portable units; mix HydraClean at a rate of 2 oz. per 5 gallons of water. In truckmount units; mix 1 quart of HydraClean with 5 gallons of water to make a concentrated solution. Set your solution flow meter from 2 to 3 gph.
4. Extract carpet thoroughly making sure to slow down in heavy soiled areas and use a dry stroke to dry the carpet faster and return it to service quicker. For faster cleaning, reduced fatigue, and more effective soil removal, extract with the **RX-20 Rotary Extraction Tool**. In furniture dense environments use the **Evolution** cleaning wand.
5. For faster drying, especially in humid environments, consider the use of an axial, centrifugal, or downdraft air mover after cleaning.

Instrucciones:

1. Siempre antes de la prueba todas las soluciones de limpieza en un área discreta de durabilidad antes de la aplicación.
2. Seleccionar y aplicar el acondicionamiento HydraMaster adecuada formación agraria solución en primer lugar.
3. Para unidades portátiles - mezclar HydraClean a un ritmo de 2 oz. por cada 5 galones de agua. En truckmount unidades - mezclar 1 cuarto de galón de HydraClean con 5 galones de agua para hacer una solución concentrada. Configurar el medidor de caudal de solución de 2 a 3 gph.
4. Extracto alfombra completamente asegurándose de que para frenar el fuerte en las superficies manchadas y utilizar un seco golpe para secar la alfombra más rápido y vuelva a ponerlo en servicio más rápido. Para una mayor limpieza, reducción de la fatiga, y más eficaz del suelo extracción, extracto con el RX-20 Rotary Herramienta de extracción. Muebles en entornos de alta densidad uso la evolución limpieza varita.
5. Para un secado más rápido, especialmente en ambientes húmedos, considere el uso de un axial, centrifugos, aire descendente o transportador después de realizar la limpieza.
